Report Background

Overview


This report draws on a two-wave nationally representative CivicPulse survey of local elected officials conducted in Fall 2022. The first wave preceded the November elections, while the second wave coincided with the elections. Respondents were asked to report both their actual experiences of being insulted, harassed, threatened or attacked as well as whether they were concerned about such events occurring. Results are broken out both by survey wave and demographic groups.

Key Findings

- 1— High levels of hostility toward local elected leaders
- 2 Hostile experiences especially common for women and minority officials
- 3 2022 election period saw a modest decline in hostility


Experiences with hostile events

Insults and harassment were widespread, and threats were not uncommon.




Concern with hostile events

While reported experiences
of attacks were rare,
almost one-infive respondents were
concerned about them.



Experiences with hostile events, by demographics


Democratic officials were more likely to report being insulted and harassed, while Republican officials were more likely to report being threatened. Both women and minority officials were much more likely to report being insulted, harassed, and threatened compared to men and non-minority officials.

Concern with hostile events, by demographics


Democratic officials were more worried about all types of hostile events than Republican officials. Women and racial/ethnic minority officials were much more worried about such events than men and non-minority respondents.



Experiences with hostile events, by time period

Hostile events across all categories dropped modestly between the summer and fall of 2022.


% Having experienced event in the preceding 3 months
